Subject: Arrangements for WCPFC20 and associated meetings

Dear All,

I am pleased to confirm meeting arrangements for the Twentieth Regular Session of the Commission for the Conservation and Management of Highly Migratory Fish Stocks in the Western and Central Pacific Ocean (WCPFC20), to take place in Rarotonga, Cook Islands. WCPFC20 will convene from 4th-8th December 2023, with associated meetings to convene on 3rd December 2023. All meetings will be held at the Cook Islands National Auditorium (see attached Meeting Information for venue details).

Seventeenth Finance and Administration Committee Meeting (FAC17)

The Finance and Administration Committee will start its 17th Regular Session at 10:00 am on **Sunday, 3 December 2023**. The FAC17 provisional agenda will be circulated in due course.

WCPFC20 Heads of Delegation Meeting

The Heads of Delegation meeting will take place at 4:00 pm on **Sunday, 3 December 2023**, to review arrangements for WCPFC20 and exchange views on making the best use of the time available for WCPFC20. The agenda for the HOD will be posted in due course.

Submission of Proposals

CCMs should submit draft proposals for the Commission's consideration at least 30 days in advance of the regular session, or by **Saturday, 4 November 2023**. Please send submissions to the WCPFC Executive Director: Rhea.Moss-Christian@wcpfc.int.

Hybrid Meeting

WCPFC20 will be an in-person and virtual meeting, with virtual participation through Zoom. Virtual participants will have access to WCPFC20 plenary sessions, as well as HODs meetings, breakout out sessions and FAC that takes place in the main meeting room during WCPFC. Interventions done virtually from CCMs will only be permitted if an HOD or an alternative is not able to attend the meeting physically. If a CCM is unable to physically attend the meeting please contact the Secretariat's Finance and Administration Manager, Aaron Nighswander (Aaron.Nighswander@wcpfc.int) so technical arrangements can be made.

Registration

All participants are requested to register electronically through the WCPFC website at <https://meetings.wcpfc.int/meetings/wcpfc20>. Participants are required to register by **Monday, 27 November 2023**. Late registrations may result in delays in entering the meeting venue or up to a 24-hour delay if joining the meeting via Zoom.

In accordance with Rules 6 and 36 of the Commission's Rules of Procedure, Members, Cooperating Non-Members, Participating Territories, Observers and other participants planning to attend WCPFC20 are requested to submit contact details for official contacts, designated representatives, alternate representatives and advisers to WCPFC Administrative Officer, Lucille Martinez (Lucille.Martinez@wcpfc.int) by **Monday, 13 November 2023**.

As decided at WCPFC13, a fee will be charged to non-governmental organizations (NGOs) for their participation at Commission meetings, unless otherwise decided by the Commission. For WCPFC20, the fee for the first two delegates per NGO is US\$500, and US\$350 for each subsequent NGO delegate who will be attending the meeting physically. For those NGO delegates attending virtually, the fee is US\$250 for the first two delegates and US\$150 for each subsequent delegate. Payments should be made via bank wire to the WCPFC Secretariat and must be received no later than **Monday, 13 November 2023**.

The Commission will provide support to assist the participation of one formally nominated representative from each developing country and participating territory that is a member of the Commission, in the form of a daily subsistence allowance (DSA) and economy airfare utilizing the most direct economical route available. Developing country and participating territory nominations should be submitted to the Secretariat's Finance and Administration Manager, Aaron Nighswander (Aaron.Nighswander@wcpfc.int) by **Wednesday, 1 November 2023**. Late nominations, including changes to any completed bookings, are unlikely to be accommodated as they add significantly to the costs of travel.

The meeting venue is the Cook Islands National Auditorium. It is located on the northern side of the island within the main township of Avarua, on the island of Rarotonga (see map). FAC17, Heads of Delegation, and WCPFC20 meetings will take place here.
